Lot Twenty-six (26) of KEPHART'S ADDITION TO ST. CHARLES, IOWA, PLAT NO. 2, a subdivision in the City of St. Charles, Madison County, Iowa. (locally known as 411 W. Carpenter St., St. Charles, IA 50240)
