

Plastic distribution box in working condition. Hydraulic load tested the 4x95ft=380ft rock and pipe laterals with 400 gal water. All laterals took water and probed dry and clean.

- Revisit all components to verify lids are secure.
- Gather all tools for removal from the site.
- Verify that no sewage is on the ground surface.
