NOTICE OF TERMINATION

THIS NOTICE OF TERMINATION (this "Notice") is made this 17 day of March, 2020 by Invenergy Wind Development LLC, a Delaware limited liability company with its principal place of business at One South Wacker Drive, Suite 1800, Chicago, Illinois 60606 ("Grantee").

WHEREAS, Grantee and Gary Davis, a single person, as contract purchaser, subject to the right of Donald E. Ham, a single person, as contract seller (collectively, "Owner") entered into that certain Agreement Regarding Easements dated July 10, 2018, as evidenced by that certain Memorandum of Agreement Regarding Easements of even date recorded August 8, 2018 in Book 2018, Page 2571, in the official public records of Madison County, Iowa, which Agreement encumbers that certain real property described on Exhibit A attached hereto and incorporated herein by this reference; and
