WHEREAS, Grantee and Elaine M. 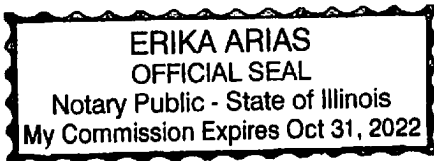
