NOTICE OF TERMINATION

THIS NOTICE OF TERMINATION (this "Notice") is made this 17 day of March, 2020 by Bridges Wind Energy LLC, a Delaware limited liability company with its principal place of business at One South Wacker Drive, Suite 1800, Chicago, Illinois 60606 ("Grantee").

WHEREAS, Grantee and Ida R. Eivins, a single person (collectively, "Owner") entered into that certain Agreement Regarding Easements dated February 27, 2019, as evidenced by that certain Memorandum of Agreement Regarding Easements of even date recorded March 26, 2019 in Book 2019, Page 884, in the official public records of Madison County, Iowa, which Agreement encumbers that certain real property described on Exhibit A attached hereto and incorporated herein by this reference; and


Grantee hereby is providing notice that the Agreement has been terminated effective March 30, 2020.
