## AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS FOR NORTH STONE VILLAGE TOWNHOMES

This Amendment to the Declaration of Covenants, Conditions, and Restrictions for North Stone Village Townhomes is made on the date set forth below by North Stone Townhomes, LLC:

- 1. Lot Seven (7) of North Stone Village, Plat No. 6, an Addition to the City of Winterset, Madison County, Iowa, which has been divided into Lots 7A and 7B as shown in Plat of Survey recorded on February 18, 2020, in Book 2020, Page 513 of the Recorder's Office of Madison County, Iowa, is hereby added to the Declaration of Covenants, Conditions, and Restrictions for North Stone Village Townhomes, recorded on December 27, 2017, in Book 2017, Page 4093 of the Recorder's Office of Madison County, Iowa.
- 2. The floor plan for the building consisting of two townhome units to be constructed on each lot is substantially the same as the floor plans attached as Exhibit "B" of the Declaration of Covenants, Conditions, and Restrictions for North Stone Village Townhomes.
- 3. In all other respects the Declaration of Covenants, Conditions, and Restrictions for North Stone Village Townhomes are hereby ratified and confirmed.
