TRUSTEE WARRANTY DEED

For the consideration of One (\$1.00) Dollar(s) and other valuable consideration, Todd C. Town and Deborah A. Town, Trustees of the Town Family Trust dated August 28, 2000, does hereby convey to Matthew A. Christy, a single person, the following described real estate:

Parcel "A" located in the Southeast Quarter (1/4) of the Northwest Quarter (1/4) of Section Three (3), Township Seventy-five (75) North, Range Twentyseven (27) West of the 5th P.M., Madison County, Iowa, containing 5.000 acres, as shown in Plat of Survey filed in Book 2, Page 521 on December 6, 1994, in the Office of the Recorder of Madison County, Iowa.

Subject to all covenants, restrictions and easements of record.
