The West Half (½) of the Northeast Quarter (¼) and the East Half (½) of the Northwest Quarter (¼) of Section Fifteen (15) and the East Half (½) of the Southwest Quarter (¼) of Section Sixteen (16), all in Township Seventy-four (74) North, Range Twenty-eight (28) West of the 5th P.M., EXCEPT the following 4 parcels:

- (1) A parcel of land described as commencing at the Southwest corner of the Northeast Quarter (¼) of Section Fifteen (15), Township Seventy-four (74) North, Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa, thence North 0°00' 279.1 feet to point of beginning; thence North 0°00' 189.4 feet; thence North 89°56' East 142.9 feet; thence South 1°10' West 196.8 feet; thence North 87°03' West 139.1 feet to point of beginning containing 0.625 acres including 0.197 acres county road right of way.
