## **QUIT CLAIM DEED**

Thompson, as Tenant with Full Rights of Survivorship, all our right, title, interest, estate, claim and demand in the following described real estate in Madison County, Iowa:

That part of Parcel C, recorded in Book 2001 Page 4525, of the Northeast Quarter of the Southeast Quarter of Section 24, Township 76 North, Range 26 West of the 5<sup>th</sup> P.M., Madison County, Iowa, described as follows;

Beginning at the Southeast corner of said Northeast Quarter of the Southeast Quarter said point also being the Southeast corner of said Parcel C; thence south 82 degrees 18 minutes 56 seconds West, 1,286.09 feet to the Southwest corner of said Parcel C and the Southwest corner of said Northeast Quarter of the Southeast Quarter; thence North 00 degrees 37 minutes 46 seconds West, 70.08 feet along the West line of said Parcel C; thence North 83 degrees 36 minutes 11 seconds East, 1,282.78 feet to the East line of said Parcel C and the East line of said Northeast Quarter of the Southeast Quarter; thence South 00 degrees 43 minutes 06 seconds East, 41.03 feet to the Point of Beginning, having an area of 1.63 Acres including 0.04 acres of Madison County Road Easement.
