1. Parcel "B" in the Northeast Quarter of the Northwest Quarter of Section 24, Township 76 North, Range 29 West of the 5th P.M., Madison County, Iowa more particularly described as follows: Beginning at the North Quarter Corner of Section 24, Township 76 North, Range 29 West of the 5th P.M., Madison County, Iowa thence South 00°34'14" East 209.76 feet along the East line of the Northeast Quarter of the Northwest Quarter of said Section 24; thence North 89°31'37" West 391.85 feet; thence South 01°15'16" West 144.71 feet; thence South 87°18'21" West 448.67 feet; thence South 00°54'05" East 137.13 feet; thence North 89°37'30" West 477.17 feet to a point on the West line of said Northeast Quarter of the Northwest Quarter; thence North 00°43'51" West 502.01 feet to the Northwest Corner of said Northeast Quarter of the Northwest Quarter; thence North 89°48'49" East 1322.50 feet to the Point of Beginning containing 11.12 acres including 1.46 acres of County Road right-of-way, AND

The East 75 Acres of the South Half (S1/2) of the Southwest Quarter (1/4), and the East 70 Rods of the South 11.43 Rods of the Northwest Quarter (1/4) of the Southwest Quarter (1/4) and the Northeast Quarter (1/4) of the Southwest Quarter (1/4) except 12 Acres more or less described as commencing at the Northeast corner of said 40-acres tract and running West 27 rods to a certain branch, thence South along said branch to the South line of said 40-acre tract, thence East 22 rods to the Southeast corner thereof, thence North to the point of beginning, all in Section Thirteen (13), in Township Seventy-six (76) North, Range Twenty-nine (29) West of the 5th P.M., Madison County, Iowa, including Parcel "C".
