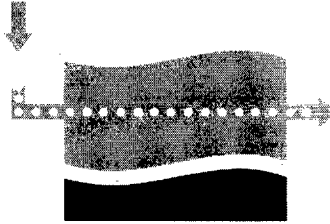

- Verify that no sewage is on the ground surface.

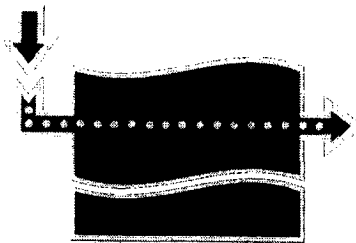
