

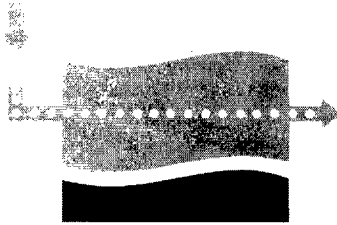

All waste water goes from house to septic. 2000 gal concrete tank in working condition. Plastic distribution box in working condition. Hydraulic load tested the 5x90ft=450ft 36" Chambers with 400 gal water. All chambers took water well and probed dry and clean.

- Revisit all components to verify lids are secure.
- Gather all tools for removal from the site.
- Verify that no sewage is on the ground surface.
