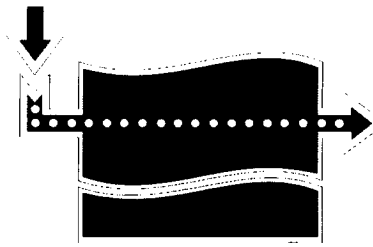

All waste water goes from house to septic. 1500 gal concrete tank with riser and outlet filter in working condition. Plastic distribution box in working condition. Hydraulic load tested the 4x80ft=320ft 36" Chambers with 350 gal water. All laterals took water and probed dry and clean.

- Verify that controls are set on the appropriate mode.
- Power is on to all components.
- Revisit all components to verify lids are secure.
- Gather all tools for removal from the site.
- Verify that no sewage is on the ground surface.

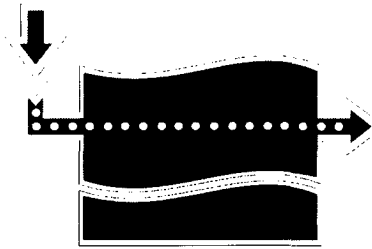
