ADDENDUM

No. 1

The West One-half (1/2) of the Northwest Quarter (1/4) which is East of present road and the roadbed South of river, the Northeast Quarter (1/4) of the Southwest Quarter (1/4) all in Section Thirty-four (34), Township Seventy-four (74) North, Range Twenty-six (26) West of the 5th P.M., Madison County, Iowa, and an easement to a tract described as beginning 20 feet North of the Northeast corner of the Northwest Quarter (1/4) of the Southwest Quarter (1/4) of Section Thirty-four (34), thence South twenty (20) feet, thence East twenty (20) feet, thence northwesterly to the point of beginning, together with all easements and servient estates appurtenant thereto

EXCEPT

Parcel "A" located in the Northwest Quarter of the Northwest Quarter of Section 34, Township 74 North, Range 26 West of the 5th P.M., Madison County, Iowa, as shown in the Plat of Survey recorded in Book 2015, Page 944 of the Recorder's Office of Madison County, Iowa.
