That K&B, L.L.C. is now the record titleholder of the following described real estate situated in Madison County, to-wit:

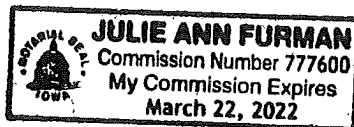

The West 7.75 chains of the North 8.50 chains of the Southeast Quarter ( $\frac{1}{4}$ ) of the Southeast Quarter ( $\frac{1}{4}$ ), and the North Half ( $\frac{1}{2}$ ) of the Southeast Quarter ( $\frac{1}{4}$ ), and the Southwest Quarter ( $\frac{1}{4}$ ) of the Southeast Quarter ( $\frac{1}{4}$ ) of Section Twenty-eight (28), Township Seventy-four (74) North, Range Twenty-seven (27) West of the 5<sup>th</sup> P.M., Madison County, Iowa, EXCEPT the following described tracts to-wit:

1. The right of way deeded to the Chicago, St. Paul & Kansas City Railway Company more particularly described as follows: A strip of land 100 feet in width extending over and across the North Half ( $\frac{1}{2}$ ) of the Southeast Quarter ( $\frac{1}{4}$ ) and the Southwest Quarter ( $\frac{1}{4}$ ) of the Southeast Quarter ( $\frac{1}{4}$ ) of said Section Twenty-eight (28), said strip of land being 50 feet in width on each side of the center line of the main track (now removed) of the Chicago, St. Paul and Kansas City Railway Company (later the Chicago Great Western Railway Company, now the Chicago and North Western Transportation Company) as said main track center line was originally located and established over and across said Section Twenty-eight (28),
2. The North Half ( $\frac{1}{2}$ ) of the Northeast Quarter ( $\frac{1}{4}$ ) of Section Thirty-three (33), Township Seventy-four (74) North, Range Twenty-seven (27) West of the 5<sup>th</sup> P.M., Madison County, Iowa, EXCEPT a tract described as follows: Beginning at the Northwest corner of the Northeast Quarter ( $\frac{1}{4}$ ) of said Section Thirty-three (33), thence on an assumed bearing of South 00°55'17" West 1324.49 feet, thence North 90°00'00" East 33.00 feet, thence North 05°46'52" East 469.45 feet, thence North 00°37'48" East 250.82 feet, thence North 00°31'03" West 300.70 feet, thence North 13°31'07" East 185.54 feet, thence North 00°31'03" West 120.0 feet, thence North 71°30'29" West 16.91 feet to the North line of said Northeast Quarter ( $\frac{1}{4}$ ), thence North 90°00'00" West 85.28 feet along said North line to the point of beginning and containing 2.09 acres more or less, including present highway.
