There is a 2 Rod (33') gap in land created by the Plat of Stover Addition Plat 1 and the Warranty Deed in Book 102 Page 406. The area of concern is noted on this Plat. Also an extensive search was made to locate the origin of the iron pipe that were set near the boundary lines. An adjacent landowner was contacted and no records were found. 1/2"Iron pipes were not accepted at A,B,C. Also capped iron rods at D,E were not accepted. At F an iron rod found is 0.35'S of deed line. At G there are multiple monuments. The South iron rod is 0.25 N of deed line the others being further North.
