District and landowner are executing this agreement to satisfy the requirements of lowa Code Section 161A.73. Iowa Code Section 161A.73 requires this agreement as a condition for receiving financial assistance and provides that the owner, present or future, of the property described in this agreement is responsible if the soil and water conservation practice is not maintained or is removed, altered or modified while this agreement is in effect.

For a period of 20 years, beginning upon final inspection of the practice by the certifying technician on 11/16/16, the landowner or landowner's successors:

 - Maintaining seeding associated with the practice and ensuring sufficient cover or stand;
 - Removal of invasive plants/vegetation that could interfere with the performance of the practice;
 - Repairing damage caused by wind, water or burrowing animals; C.
 - Ensuring intakes and outlets are free of debris or sediment and function properly, including emergency spillways and outlets: d.
 - Avoiding tillage, chemical drift or any other action that could threaten the integrity of a practice; and
- Cover crops shall not be mechanically or chemically terminated prior to the spring of the following planting season.
- Agree that if the practice is removed, altered or modified, they will repair or reconstruct the practice at their own expense. In lieu of repairing or reconstructing the practices, the district, at its sole discretion, may allow landowner or landowner's successors to refund to the Division of Soil Conservation and Water Quality the entire amount of the financial incentive payment made to implement the conservation practice.
