AFFIDAVIT OF SURVIVING SPOUSE FOR CHANGE OF TITLE TO REAL ESTATE

- I, Betty Lou Hendrickson being first duly sworn on oath, depose and state as follows:
- 1. Ruby I. Hendrickson, a/k/a Ruby Hendrickson, was the surviving spouse of E. A. Hendrickson, a/k/a Elias Anthony Hendrickson, who died on the 16th day of August, 1982.
- 2. The following described real estate was owned only by E. A. Hendrickson, a/k/a Elias Anthony Hendrickson, and Ruby I. Hendrickson, a/k/a Ruby Hendrickson, as joint tenants with full rights of survivorship at the time of E. A. Hendrickson, a/k/a Elias Anthony Hendrickson's death:

Lot Four (4) of the Re-Subdivision of Block Twenty (20) of Pitzer & Knight's Addition to the Town of Winterset, Madison County, Iowa.



- 3. Title was conveyed to E. A. Hendrickson and Ruby I. Hendrickson by instrument filed on June 2, 1969, in Book 42 at Page 524.
- 4. Ruby Hendrickson died on the 24th day of June, 2020.
- 5. On the 9th day of July, 2020, the Last Will and Testament of Ruby Hendrickson, deceased, bearing the date of the 1st day of July, 2004, was admitted to probate in the Iowa District Court for Madison County and Betty Lou Hendrickson was appointed Executor of the Estate of Ruby Hendrickson.
- 6. I hereby request that the Auditor enter this information on the transfer books pursuant to Section 558.66 of the Iowa Code.
- 7. Form 706, United States Estate Tax return, **WAS NOT** required to be filed as a result of the death of E. A. Hendrickson, a/k/a Elias Anthony Hendrickson.
- 8. An Iowa inheritance tax return was not required to be filed pursuant to Iowa Code Section 450.22 subsection 3 regarding the death of E. A. Hendrickson, a/k/a Elias Anthony Hendrickson.
