**ASSIGNMENT OF COLLATERAL DOCUMENT**

**THIS ASSIGNMENT OF COLLATERAL DOCUMENTS** (this "ASSIGNMENT") is made as the 22nd day of December, 2020, between **Central Bank as Attorney-in-Fact for MetaBank**, a federally chartered stock savings bank, now known as **MetaBank, N. A.** (the "Assignor"), and **Central Bank**, an Iowa State Chartered Bank, whose address is 600 Lake Avenue, Storm Lake, IA 50588 (the "Assignee").

**WITNESSETH:**

**WHEREAS**, the Assignor wishes to assign a certain Subordination, Non-Disturbance and Attornment Agreement to Assignee under the terms of a Branch Purchase and Assumption Agreement dated November 20, 2019.

**NOW THEREFORE**, in consideration of the premises of the sum of One and No/100ths Dollar (\$1.00) paid, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Assignor does hereby grant, transfer, set over, assign and deliver to the Assignee all of the Assignor's right, title and interest in, to a certain Subordination, Non-Disturbance and Attornment Agreement made and executed by MetaBank, a South Dakota banking corporation (Lender), Hy-Vee, Inc., an Iowa corporation (Tenant) and Hurd & Daughter, LLC, an Iowa limited liability company (Landlord) including all modifications, extensions, and amendments, dated February 26, 2016, filed February 26, 2016 as Book 2016, Page 483 in the office of the Recorder in and for Madison County, Iowa. Legally described as:
