FENCE AGREEMENT

WHEREAS, Kent Kiburz, a married individual, is the owner of the following described property:

The Southwest Quarter (SW1/4) of the Northwest Quarter (NW1/4) of Section Thirty-four (34), Township Seventy-six (76) North, Range Twenty-nine (29) West of the 5th P.M., Madison County, Iowa.

WHEREAS, the parties hereto are desirous of making an agreement as to the construction, maintenance and location of a partition fence between their properties.
