After a properly held Public Hearing on February 2, 2021, the Madison County Board of Adjustment hereby grants an Amendment to the Conditional Use Permit issued on July 16, 1971 on the following described real estate: **Sections 33 & 34 T76N R27W-Union Township 2490 State Highway 92** for the purpose of:

The addition of approximately 116 acres additional waste disposal acres as shown on the attached map. This amendment, which is numbered separate, becomes a part of the existing CUP and does not change any of the previously approved authorization, restrictions or requirements.

The Amendment to the existing Conditional Use permit is granted as required by the Madison County Zoning Ordinance under Section: 14 -E 3(B)- Sanitary Land Fill Dump- premise used for dumping organic materials such as garbage in an excavation and covered daily with dirt in accordance with Board of Health requirements.




Therefore, after consideration of all these factors, which are incorporated by reference herein, the Board of Adjustment hereby finds and concludes:





DECISION

On February 2, 2021 at 7:00 p.m., pursuant to the rules of procedure of the Madison County Board of Adjustment, a public hearing was held and conducted on the Application for Amendment to previously issued Special Use Permit dated July 16, 1971 that established and authorized a sanitary land fill operation. The requested amendment was to add additional land to increase the solid waste disposal area in sections 33 & 34 of Union Township. At the hearing the Board of Adjustment, reviewed the completed application form(s), relevant provisions of the Madison County Ordinances, all documents constituting the record from the Zoning Administrator, documents received from the applicant, heard the statements, remarks and comments by the Zoning Administrator, the applicant, South Central Iowa Landfill Agency, as well as statements, remarks and comments by others in attendance. After all the information was received and all interest parties were heard by the Board of Adjustment, the hearing was closed pursuant to the rules of procedure of the Board of Adjustment.
