AFFIDAVIT OF SURVIVING JOINT TENANT FOR CHANGE OF TITLE TO REAL ESTATE

- I, Allan Searl, being first duly sworn on oath, depose and state as follows:
- 1. Donna Dudney is the surviving joint tenant of Patricia J. Lawr (the "Decedent"), who died on December 7, 2011.
- 2. The following described real estate was owned only by Decedent and Donna Dudney, as joint tenants with full rights of survivorship at the time of the Decedent's death:

- 5. Allan Searl, is the son of Donna Dudney, deceased. (For deaths occurring after July 1, 1997, parents, grandparents, great-grandparents, and other lineal ascendants, children including legally adopted children and biological children entitled to inherit under the laws of Iowa, stepchildren, and grandchildren, greatgrandchildren, and other lineal descendants are exempt from Iowa inheritance tax.)
- 6. Form 706, United States Estate Tax return, IS NOT* required to be filed as a result of the death of the Decedent.

7. An Iowa inheritance tax return is not required to be filed pursuant to section 450.22 subsection 3.
