WARRANTY DEED
JOINT TENANCY

For the consideration of \$1.00 and no/100ths... Dollar(s) and other valuable consideration, RHONDA R. ALLEN and MYRON P. ALLEN, JR., wife and husband, do hereby Convey to MYRON P. Lots 4, 5, 6, 9 and 10 in Block 8 of Barker's Second Addition to the Town of Macksburg and the Alley lying South of Lots 4, 5 and 6 and the West half of the Alley lying East of Lots 9 and 10 in said Block 8.

This is a transfer between husband and wife without actual consideration; therefore, this transfer is exempt from the Iowa real estate transfer tax and declaration of value and groundwater hazard statement filing requirements pursuant to Section 428A.2(11). Code of Iowa.
