WARRANTY DEED

An undivided one-fourth interest in and to:

The East One-half of the Southeast Quarter (E½ SE¼) of Section 8; AND the Southwest Quarter (SW¼) of Section 9, all in Township 77 North, Range 28 West of the 5th P.M., Madison County, Iowa, EXCEPT the right of way of the Chicago, Rock Island & Pacific Railway Company, located in the East One-half of the Southwest Quarter (E½ SW¼) of said Section 9..

Monetary consideration is less than \$500; therefore, this transfer is exempt from the Iowa real estate transfer tax and declaration of value and groundwater hazard statement filing requirements pursuant to Section 428A.2(21), Code of Iowa.

Words and phrases herein, including acknowledgment hereof, shall be construed as in the singular or plural number, and as masculine or feminine gender, according to the context.

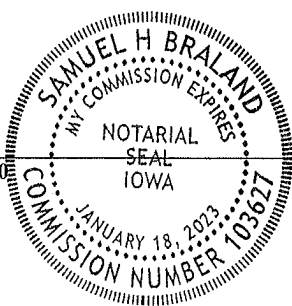
