RIGHT OF FIRST REFUSAL

FOR GOOD AND VALUABLE CONSIDERATION, Troy D. Strawn and Amy B.

Said real property shall be appraised based on the value of the land, plus all improvements or for its use as agricultural value. Said appraisal shall not be based on its value for use as a subdivision.
