Lot One A (1A) of North Stone Village, Plat No. 7, City of Winterset, Madison County, Iowa. 



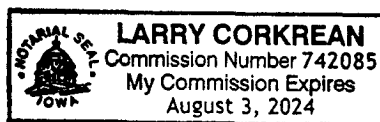
