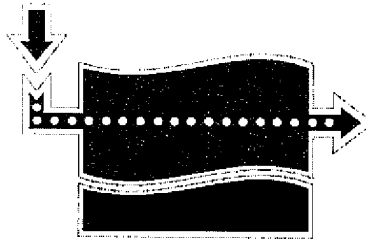

All waste water goes from house to septic. 2000 gal concrete tank with risers and outlet filter in working condition. 1000 gal concrete pump tank in working condition. Lift pump, alarm and all floats in working condition. Hydraulic load tested the 10ft x 114ft at grade mound with 350 gal water. Mound took water well and probed dry and clean.

Site status at conclusion of Time of Transfer inspection:

- Verify that controls are set on the appropriate mode.
- Power is on to all components.
- Revisit all components to verify lids are secure.
- Gather all tools for removal from the site.
- Verify that no sewage is on the ground surface.

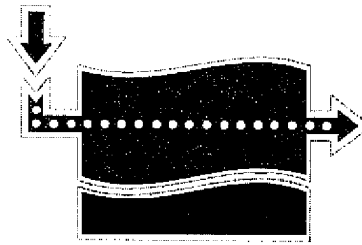
