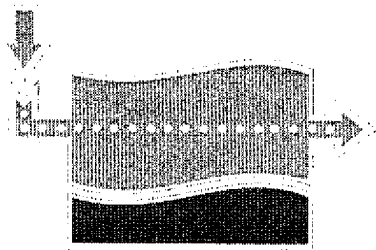

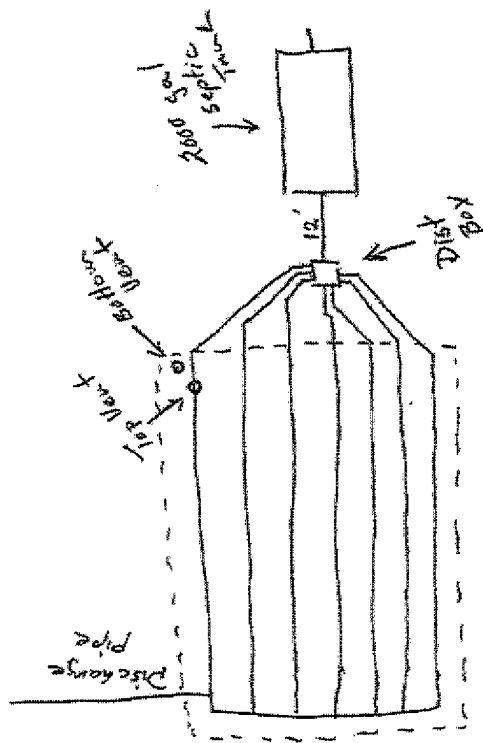

Hydraulic load tested the 20ft x 40ft sand filter with 400 gal water. Sand filter took all water at this time. Could not collect a water sample at this time as the discharge pipe is frozen solid.

- Revisit all components to verify lids are secure.
- Gather all tools for removal from the site.
- Verify that no sewage is on the ground surface.

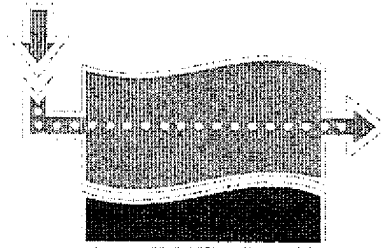
