



WARRANTY DEED

For the consideration of Sixty Thousand Dollar(s) and other valuable consideration, Sabrina K. McVay, single, does hereby Convey to Blaine Lowden, the following described real estate in Madison County, Iowa:

The East Half ($\frac{1}{2}$) of the Southwest Quarter ($\frac{1}{4}$) of Block Fourteen (14), of Pitzer & Knight's Addition to the City of Winterset, Iowa, except the North Eight and One-Fourth ($\frac{8}{4}$) feet in width thereof.

There is no known private burial site, well, solid waste disposal site, underground storage tank, hazardous waste, or private sewage disposal system on the property as described in Iowa Code Section 558.69, and therefore the transaction is exempt from the requirement to submit a groundwater hazard statement.
