**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION
OF ANCHORED WALLS, INC.**

Pursuant to the provisions of Section 490.1006 of the Code of Iowa, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I

The name of the corporation is Anchored Walls, Inc.

ARTICLE II

The following amendment to the Articles of Incorporation was adopted by the shareholders of the corporation on July 11, 1998, in the manner prescribed by the Iowa Business Corporation Act:

Article III of the Articles of Incorporation is hereby amended to read as follows:

DURATION

This corporation shall have perpetual duration.

ARTICLE III

The date of such amendment adoption was July 11, 1998.

ARTICLE IV

The number of shares of the corporation outstanding at the time of the adoption of the amendment was 28 and the number of shares entitled to vote thereon was 28.

ARTICLE V

The number of shares voting for such amendment was 28 and the number of shares voting against such amendment was 0.

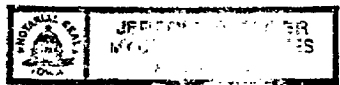
