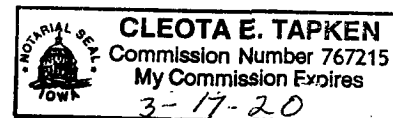

RESOLUTION DIRECTING THE SALE OF AN INTEREST IN REAL PROPERTY
FOLLOWING THE PUBLIC HEARING

BE IT RESOLVED by the Council of the City of St. Charles, Iowa:

NOW on this 7th day of October 2019, on behalf of the City of St. Charles, Iowa, the Mayor shall sell and deed an interest in real property which is described as follows:

The 16 foot alley running north and south and lying east of and adjacent to Lot 4 in Block 9 of Hartman & Young's Addition to St. Charles, Madison County, Iowa.

to the owner or owners of the lots abutting the aforementioned alley, named as grantees on the Quit Claim Deeds, with the City retaining all easements of record, copies of which are attached to this Resolution and by this referenced made a part hereof, for a sum of \$1.00 plus legal fees and costs and for other good and valuable consideration. The City Clerk shall co-sign all deeds. The deed shall be delivered thirty (30) days after the date of this Resolution unless an appeal on this action has been made to the District Court. Action on this Resolution shall be final upon the purchaser of the deed giving evidence to the City Clerk that the deed has been recorded, and such fact noted on the official record of this Resolution.
