## TRUSTEE WARRANTY DEED

KNOW ALL PERSONS BY THIS DEED: That Jeffrey D. Moser and Rachelle A. Moser, Trustees of the Jeffrey and Rachelle Moser Joint Revocable Trust dated June 28. 2018 (the "Grantor"), do hereby Convey to Ryan Todd Pittman and Kassondra Lea Pittman. a married couple (the "Grantees"), as joint tenants with full rights of survivorship and not as tenants in common, the following-described real estate:

Lot Fourteen (14) of CORKREAN & WATTS ADDITION PLAT NO. 6, an Addition to the City of Winterset, Madison County, Iowa.

There is no known private burial site, well, solid waste disposal site, underground storage tank, hazardous waste, or private sewage disposal system on the property as described in Iowa Code section 558.69, and therefore the transaction is exempt from the requirement to submit a groundwater hazard statement.

The Grantor does hereby covenant with Grantees, and successors in interest, that Grantor holds the real estate by title in fee simple; that Grantor has good and lawful authority to sell and convey the real estate; that the real estate is free and clear of all liens and encumbrances except covenants, restrictions and easements of record. The Grantor further warrants to the Grantees all of the following: that the trust pursuant to which the transfer is made is duly executed and in existence; that the person creating the trust was under no disability or infirmity at the time the trust was created; that the transfer by the Trustees to the Grantees is effective and rightful; and that the Trustees know of no facts or legal claims which might impair the validity of the trust or the validity of the transfer.
