- 4. That I am the surviving spouse, and surviving joint tenant of Fred L. Gibson, who died on December 19, 2022, thereby terminating the Life Estate held by him in and to the real estate identified above.

- 5. That a Federal Form 706, United States Estate Tax return was not required to be filed as a result of the death of Fred L. Gibson; and, that an Iowa Inheritance Tax return was not required to be filed as a result of the death of Fred L. Gibson.
