For the consideration of One Dollar(s) and other valuable consideration, Clayton D. Hayden and Carla Kay May, Co-Trustees of the Carroll D. Hayden Revocable Trust, does hereby Convey to Carla Kay May and Donal R. May, as joint tenants with full rights of survivorship and not as tenants in common, the following described real estate in Madison County, Iowa:

Parcel DD as shown in the Plat of Survey of that part of the South Quarter (1/4) of the Northwest Quarter (1/4) of Section 23, Township 75 North, Range 26 West of the 5th P.M., Madison County, Iowa, recorded May 7, 2024, in Book 2024, Page 981 of the Recorder's Office of Madison County, Iowa, AND The Northeast Quarter (1/4) of the Northeast Quarter (1/4) of Section Twentytwo (22), Township Seventy-five (75) North, Range Twenty-six (26) West of the 5<sup>th</sup> P.M., Madison County, Iowa: EXCEPT the following-described tracts, to-wit:

- 1. A tract of land located therein and more particularly described as follows, to-wit: Commencing at a point 12 rods and 6 inches North of the Southwest corner of the Northeast Quarter (1/4) of the Northeast Quarter (1/4), running thence North 10 rods, thence East 16 rods, thence South 13 rods and 6 inches, thence West 16 rods, thence North 3 rods and 6 inches to the place of beginning.
