Iowa Financial Incentive Program Maintenance/Performance Agreement
Iowa Department of Agriculture & Land Stewardship - Division of Soil Conservation and Water Quality

This agreement is made and entered into by and between the <u>MADISON</u> Soil and Water Conservation District, herein called District, and <u>Ryan Breeding</u>, herein called Landowner. Witnesseth:

District and Landowner are executing this agreement to satisfy the requirements of Iowa Code Section 161A.7(3). Iowa Code Section 161A.7(3) requires this agreement as a condition for receiving financial assistance and provides that the Landowner(s), present or future, of the property described in this agreement is responsible if the soil and water conservation practice is not maintained or is removed, altered or modified while this agreement is in effect.

For a period of <u>10 years</u>, beginning upon final inspection of the practice by the certifying technician on <u>June 17, 2024</u>, the Landowner's successors:

Acknowledge financial assistance as part of FARMS Agreement Number #115300 has been used to fund a soil and water conservation practice(s) on land legally described as follows: The West Half (W ½) of the Southeast Quarter (SE ¼) of Section Ten (10), Township Seventy-five (75) North, Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa, EXCEPT that part of Parcel "C" located therein, as shown in Amended Plat of Survey filed in Book 2014, Page 888 on April 16, 2014, in the Office of the Recorder of Madison County, Iowa; AND EXCEPT 6.52 acres located therein and conveyed for highway purposes; AND EXCEPT a tract of land located in the Southwest Quarter (SW ¼) of the Southeast Quarter (SE ¼) of said Section Ten (10), containing 6.0 acres, more or less, as shown in Plat of Survey filed in Plat Book 1, Page 139 on July 17, 1978, in the Office of the Recorder of Madison County, Iowa.

- 1. Agree not to remove, alter or modify the practice as built. As built practice(s): Forage and Biomass Planting, 13.1 Acres
- 2. Agree to maintain the practice(s). Maintenance includes, but is not limited to:

- a. Maintaining seeding and removal of invasive plants/vegetation that could interfere with the performance of the practice;
- b. Repairing damage caused by wind, water, burrowing animals or any activity that could threaten the integrity of the practice;
- c. Ensuring intakes and outlets are free of debris or sediment and function properly, including emergency spillways and outlets;
- d. Not mechanically or chemically terminating cover crops prior to the spring of the following planting season.
- 3. Agree that if the practice is removed, altered or modified, they will repair or reconstruct the practice at their own expense. In lieu of repairing or reconstructing the practices, the District, at its sole discretion, may allow Landowner or Landowner's successors to refund the entire amount of the financial incentive payment made to implement the conservation practice.

 Agree to notify any prospective purchaser of the property of the Landowner's obligations created by this agreement before legal or equitable title to any portion of this property is transferred.
