## **EASEMENT AGREEMENT**

McCartney Shilhanek, single, hereinafter called "Grantor", for valuable consideration, does hereby grant to Jeffrey Shoemaker and Nicole Flactiff, hereinafter called "Grantee", a perpetual Ingress-Egress Easement upon the following-described real estate:

An approximately 80' by 13' section in the middle of Lot Eight (8) of John A. Walker Subdivision, City of St. Charles, Madison County, Iowa. See attached aerial photo with the approximate easement area outlined in red. The easement area is approximately 74.5' north of the of the lot's southern boundary line and 60.5' south of the lot's northern boundary line.

Said Easement shall benefit the following described property:

Lot Seven (7) of John A. Walker Subdivision, City of St. Charles, Madison County, Iowa.

Grantor agrees to grant the Grantee an easement for ingress and egress to the property, including the right to continue to have existing improvements on the property. Grantee and Grantor agree that the expense of maintenance of the improvements shall be borne exclusively by the Grantee. Grantor covenants that no act will be permitted within the easement area which is inconsistent with the rights hereby granted. Grantor and Grantee agree that any improvements placed in the easement area by either party shall be the installing party's expense for

maintenance, repair or replacement.

This Easement shall run with the land and be binding upon successors in interest. This Easement modifies the Easement for Existing Improvements that was filed March 5, 2021, in Book 2021, Page 903 of the Recorder's Office of Madison County, Iowa, to limit down the easement area.
