Tindle, Co-Trustees of Justin Ray Tindle Trust, do hereby Convey to Lisa Marie Eddy and Nathaniel James Eddy, a married couple, as Joint Tenants with Full Rights of Survivorship and Not as Tenants in Common, the following described real estate in Madison County, Iowa:

The North Half (1/2) of Lot Four (4) in Block Twenty-eight (28) of the Original Town of Winterset, Madison County, Iowa.

There is no known private burial site, well, solid waste disposal site, underground storage tank, hazardous waste, or private sewage disposal system on the property as described in Iowa Code Section 558.69, and therefore the transaction is exempt from the requirement to submit a Groundwater Hazard Statement.

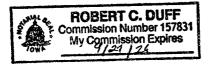
