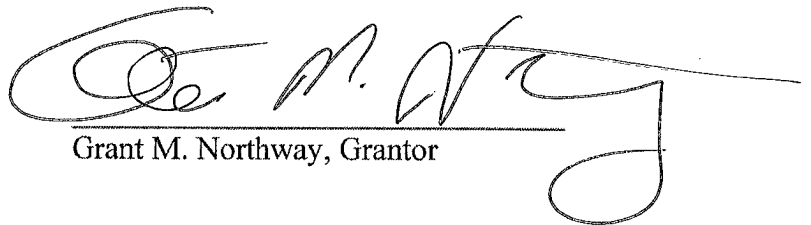
Lot One (1) of the Replat of Lot Three (3) in Helen McCall Huntoon Addition
Plat No. 3, City of Winterset, Madison County, Iowa.

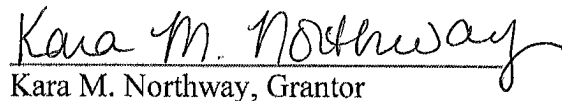
