TRUSTEE WARRANTY DEED

Exemption 428A.2(22)

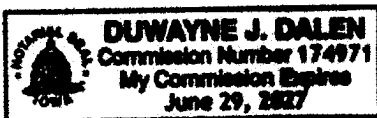
