**Background.** Mortgagor and Lender entered into a Security Instrument dated December 15, 2010 and recorded on December 16, 2010. The Security Instrument was recorded in the records of Madison County, Iowa in Book 2010, Page 3211. The property is located in MADISON County at 2259 Saint Charles Road, ST. CHARLES, IA 50240.

**Modification.** For value received, Mortgagor and Lender agree to modify the original Security Instrument. Mortgagor and Lender agree that this Modification continues the effectiveness of the original Security Instrument. The Security Instrument was given to secure the original debts and obligations (whether identified as Secured Debts, Sums Secured, or otherwise) that now have been modified. Together with this Modification, the Security Instrument now secures the following debts and all extensions, renewals, refinancings, modifications and replacements.

A promissory note between Lender and ALBERT L LITTLE and MERILYN R LITTLE (the "Borrower") dated December 15, 2010 as modified by the loan modification agreement signed by Borrower and dated the same date as this Modification (the "Loan Modification Agreement"). The Loan Modification Agreement states that Borrower owes Lender Seventeen thousand eight hundred sixty and 44/100 Dollars (U.S. \$17,860.44) plus interest. Borrower has promised to pay this debt in regular periodic payments and to pay the debt in full not later than January 5, 2030.

**Maximum Obligation Limit.** The total principal amount secured by the Security Instrument at any one time will not exceed \$17,860.44 which is a \$24,139.56 decrease in the total principal amount secured. This limitation of amount does not include interest and other fees and charges validly made pursuant to the Security Instrument. Also, this limitation does not apply to advances made under the terms of the Security Instrument to protect Lender's security and to perform any of the covenants contained in the Security Instrument.

**Warranty of Title.** Mortgagor warrants that Mortgagor is or will be lawfully seized of the estate conveyed by the Security Instrument and has the right to grant, bargain, convey, sell, and mortgage the property. Mortgagor also warrants that such same property is unencumbered, except for encumbrances of record.

**Continuation of Terms.** Except as specifically amended in this Modification, all terms of the Security Instrument remain in effect.
