NOTICE OF LIS PENDENS

Notice is hereby given that a Superseding Indictment was returned by a federal grand jury and filed by the United States of America in the United States District Court for the Southern District of Iowa on the 22nd day of July, 2009, and is now pending in this Court, involving the potential forfeiture of real property described as follows:

Real property located at 1207 Warren Avenue, Cumming, Iowa, otherwise known as:

The East 288.35 feet of the North 186 feet of the Northeast Quarter (1/4) of Section Thirteen (13), in Township Seventy-seven (77) North, Range Twenty-six (26) West of the 5th P.M., Madison County, Iowa, and a part of Lots Six (6) and Seven (7) of Rolling Acres Plat, an Official Plat of the Northeast Quarter (1/4) of said section, described as follows: Commencing at a point 288.35 feet West of the Northwest corner of said Northeast Quarter (1/4), thence South 85°00' West 139.03 feet, thence South 212 feet, thence North 85°00' West 139.03 feet, thence South 212 feet, thence North 85°32' East 427.05 feet, thence North 30 feet, thence South 85°00' West 226.35 feet, thence North 186 feet along the East line of Lot 6 to the point of beginning, all subject to road right of way along the North and East sides.

The Superseding Indictment alleges there is probable cause to believe that the Real property was used, or intended to be used, to commit, or to facilitate the commission of violations of 21 U.S.C. §§ 846 and 841.

All right, title and interest in the subject real property vested in the United States upon commission of the acts giving rise to forfeiture under 21 U.S.C. § 853.
