EASEMENT FOR PUBLIC HIGHWAY

grant to the STATE OF IOWA a permanent easement for road purposes and for use as a
Public Highway in, to, on, over, and across real estate in Madison County, Iowa:

THE EASEMENT GRANTED FOR HIGHWAY PURPOSES IS TO LAND DESCRIBED AS FOLLOWS:

A parcel of land located in the NE¼ SE¼ of Fractional Section 30, T76N, R26W of the 5th P.M., Madison County, Iowa, as shown on Acquisition Plat Exhibit "A" attached hereto and by reference made a part hereof, and more particularly described as follows:

Beginning at the E¼ Corner of said Fractional Section 30; thence S83°12'49" W 374.52 feet along the north line of the NE¼ SE¼ of said Fractional Section 30; thence S6°47'11" E 8.80 feet; thence N89°48'35" E 200.05 feet; thence S64°52'35" E 111.80 feet; thence N88°33'31" E 72.88 feet, to a point on the east line of the NE¼ SE¼ of said Fractional Section 30; thence N1°54'47" W 98.02 feet along said east line, to the E¼ Corner of said Fractional Section 30, the Point of Beginning, excepting therefrom present easements of record, containing 0.26 acre, exclusive of said exceptions.

This easement is given in fulfillment of a certain contract dated October 13, 1992, and recorded in the Madison County Recorder's Office on October 30, 1992, in Book 130, Page 578.

The additional amount of \$1,520.00, as agreed to by contract, is paid as consideration on a certain easement to Madison County, Iowa, or as severance damages to the remaining property.

This easement is being acquired for public purposes and a Declaration of Value is not required. Iowa Code Sec. 428A.1.


