## ADDENDUM TO CONTRACT

WHEREAS, the Brenton Bank and Trust Company, hereinafter referred to as "Seller", and Kenneth N. Hampshire, hereinafter referred to as "Buyer", entered into a real estate contract dated June 28, 1983, and recorded in Book 117, page 44 of the Madison County Recorder's Office,

IT IS AGREED this 5th day of March, 1993, by and between Seller and Buyer as follows:

- 1. That the outstanding principal balance is \$24,499.92, and the parties hereby agree that payment of said balance and the aforementioned contract be and is hereby extended an additional ten years under terms hereinafter set forth until June 30, 1998, at which time said contract shall be paid in full unless otherwise agreed to by written instrument.
- 2. The balance of the purchase price in the amount of \$24,499.92 shall be paid as follows: \$274.44, including interest, (or more at the option of the Buyer) ( and more as may be increased by the provisions of the last sentence of this paragraph) on or before the 30th day of January, 1993, and \$274.44, including interest ( or more at the option of the Buyer) ( and more as may be increased by the provisions of the last sentence of this paragraph) on or before the 30th day of each and every month thereafter until all sums due under this contract are paid in full, including interest on unpaid balances thereof at the rate of 11% per annum, payable monthly from December 30, 1992, until fully paid; said payments to be applied first to the interest then unpaid and next upon the balance of the principal. Accumulated interest and the outstanding principal under this contract shall be due in full on or before June 30,1998.
- 3. That all other provisions of the aforementioned real estate contract not in conflict with the foregoing provisions of this addendum shall remain unchanged and the parties hereto confirm the full force and effect of said provisions.

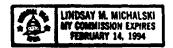
