- I, Donald D. Bush, being first duly sworn on oath, depose and state as follows:
- 1. I am the surviving spouse of Marilyn Jo Bush, who died on the 10th day of August, 2009.
- 2. The following described real estate was owned only by Marilyn Jo Bush and this Affiant, as joint tenants with full rights of survivorship at the time of Marilyn Jo Bush's death:
