Each of the undersigned hereby relinquishes all rights of dower, homestead and distributive share in and to the real estate.

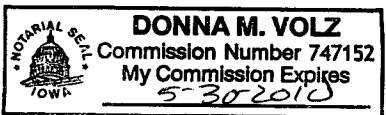

The East One-half (E 1/2) of all that part of the Southeast Quarter (SE 1/4) which lies North of the right of way of the Chicago, Rock Island and Pacific Railroad Company of Section Five (5), Township Seventy-seven (77) North, Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa, AND

Parcel "F" in the Southwest Quarter of the Northeast Quarter of Section 5, Township 77 North, Range 28 West of the 5th P.M., Madison County, Iowa, more particularly described as follows: Commencing at the center of Section 5, Township 77 North, Range 28 West of the 5th P.M.
