Each of the undersigned hereby relinquishes all rights of dower, homestead and distributive share in and to the real estate.

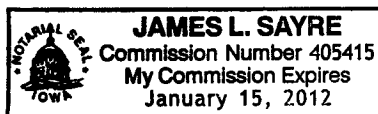

The West One-half (W 1/2) of all that part of the Southeast Quarter (SE 1/4) which lies North of the right of way of the Chicago, Rock Island and Pacific Railroad Company of Section Five (5), Township Seventy-seven (77) North, Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa EXCEPT Parcel "G" in the Northwest Quarter of the Southeast Quarter of Section Five (5), Township Seventy-seven (77) North, Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa, more particularly described as follows: Beginning at the Northeast Corner of the Northwest Quarter of the Southeast Quarter of Section 5, Township 77 North, Range 28 West of the 5th P.M., Madison County, Iowa thence South 00°46'51" East 363.00 feet along the East line of said Northwest Quarter of the Southeast Quarter; thence North 89°49'03" West 360.00 feet; thence North 00°46'51" West 363.00 feet to a point on the North line of said Northwest Quarter of the Southeast Quarter; thence South 89°49'03" East 360.00 feet to the Point of Beginning, containing 3.00 acres including 0.30 acres of County road right-of-way
