Each of the undersigned hereby relinquishes all rights of dower, homestead and distributive share in and to the real estate.

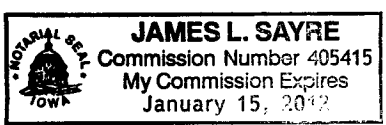

## LEGAL DESCRIPTION

### Jane E. Schirm Property

All that part of the East Half (E1/2) of the Southwest Quarter (SW1/4) of Section Five (5), Township Seventy-seven (77) North, Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa, lying North of the Chicago Rock Island & Pacific Railroad, excepting therefrom a tract described as follows: Beginning at the Northwest Corner of the East Half (E1/2) of the Southwest Quarter (SW1/4) of said Section Five (5), proceeding East 653 feet along the centerline of said Section Five (5); thence East  $89^{\circ}11'$  South 330 feet; thence  $90^{\circ}08'$  West 653 feet to the West line of the East Half of the Southwest Quarter of said Section Five; thence  $89^{\circ}52'$  North 337.8 feet to the point of beginning.
