Madison County, Iowa, thence South 89°49'03" East 120.00 feet along the South line of the Southwest Quarter of the Northeast Quarter of said Section 5 to the Point of Beginning; thence North 00°47'30" West 376.99 feet; thence North 89°58'54" East 765.53 feet; thence South 01°29'05" East 379.63 feet to a point on the South line of said Southwest Quarter of the Northeast Quarter, thence North 89°49'03" West 770.16 feet to the Point of Beginning containing 6.67 acres including 0.64 acres of County Road right-of-way;
