CITY OF WINTERSET, MADISON COUNTY, IOWA**

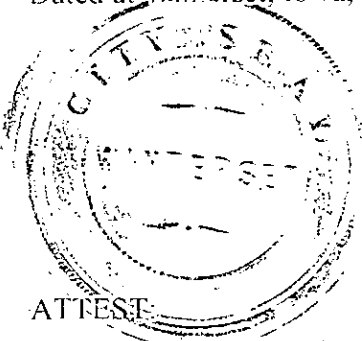
