I, Larry A. Hughes, being first duly sworn on oath, depose and state as follows:

- 1. I am the Surviving Spouse of Marilyn L. Hughes (the "decedent") who died on the the 31st day of October, 2007, and have an interest in the real estate described below by virtue of the fact that I am surviving joint tenant with respect to the real estate described below. There will be no estate proceedings instituted on account of the decedent's death.
- 2. Pursuant to Section 450.22, subsection 3 of the lowa Code, no inheritance tax return is required to be filed in the Estate of Marilyn L.
